'ND' discussed Cudmore competition, 'PB' and 'ND' to contact the ten members in question to agree their attendance at both the first and second rounds. It was suggested and agreed that the club is to pay 'en block' for all entrants, with each

entrant reimbursing the club £15 at the 1st and 2nd round. Failure to attend will still require reimbursement to the club.

'JAB' and 'JPB' mentioned a pool on Boston Boulevard suitable for fishing and which contains fish.
